

## DECLARATION OF CONFORMITY

Fratelli Guzzini S.p.A. declares that all the products intended for food contact, manufactured by the Company are in conformity to the Italian legislation and European directives applicable to them. In particular:

- the Ministerial Decree 21/03/1973 and the ISO 7086/2000 standard hollow glass objects in contact with food - Migration of lead and cadmium.

Guzzini declares that all the items are free of the following substances: DEHP – di (2-ethylhexyl) phthalate, DBP – dibutyl phthalate, BBP – benzyl butyl phthalate, DINP – di “isononyl” phthalate, DIDP – di “isodecyl” phthalate, DnOP – di-n-octyl phthalate as required by the regulation (EC) no 1907/2006 of the European Parliament and of
